8. Any notes or explanations for how you answered above?

Increased funding for ESL, smaller class sizes, and flexible scheduling create a more supportive and effective learning environment. Preserving Cantonese classes recognizes the cultural and linguistic diversity of San Francisco. Finally, balanced work-study opportunities allow students to earn a living wage while pursuing their education, reducing financial strain and promoting student success. These efforts align with CCSF's mission to serve a diverse community and empower all students to achieve their goals.

9. What will you prioritize to ensure the health, success, and longevity of the CCSF Chinatown North Beach campus?

I'll prioritize equitable access to opportunity for the Chinatown North Beach community. This means expanding Vocational ESL programs with Chinese language support, like partnerships with CityBuild Academy, to create pathways to CCSF's workforce training. It also requires advocating for increased ESL funding to offer smaller class sizes, flexible schedules, and preserve Cantonese classes. Supporting these initiatives demonstrates a commitment to serving the unique needs of this vibrant community and ensuring its residents can thrive through CCSF.

10. What are your goals to increase enrollment at the Chinatown campus?

My goal is to revitalize the Chinatown campus by making it a hub for accessible and culturally relevant education. We will achieve this by expanding Vocational English as a

Second Language (VESL) programs, offering dedicated Cantonese and Mandarin language support, and developing flexible course schedules to accommodate working students. Partnering with CityBuild Academy, local businesses, and community organizations will provide targeted workforce development opportunities, particularly in high-demand fields, connecting Chinatown residents with living-wage careers and strengthening San Francisco's economic vitality.

11. How will you ensure stabilized funding for CCSF Chinatown campus in the next few years?

Stabilizing funding for CCSF Chinatown campus requires a two-pronged approach: increasing enrollment and advocating for equitable funding allocation. I will champion expanding Vocational ESL and workforce development programs tailored to the Chinatown community's needs, attracting more students and demonstrating the campus's value. Additionally, I will actively engage with City officials, state legislators, and community stakeholders to ensure Chinatown campus receives its fair share of CCSF funding, reflecting its vital role in serving a large LEP population and contributing to San Francisco's economic vitality.

12. If elected to the City College Board of Trustees, what will be your top three priorities and how will you implement change?

My top three priorities are fiscal stability, enrollment growth, and equitable access to education.

First, we'll need to develop a data-driven, multi-year financial plan that prioritizes cost-effective solutions and pursues diverse funding sources, moving beyond reliance on "hold harmless" aid for CCSF.

Second, I'll champion expanded vocational ESL programs, especially for the Chinese LEP community, and advocate for increased ESL funding, smaller class sizes, and flexible scheduling to attract and retain students.
